Two men charged with multiple Burglary and Violent Disorder Offences

Two men have been charged with multiple burglary and violent disorder offences in Hereford and will be appearing at crown court in October.

James Smith, 31, of The Bines, Clehonger, Hereford and Tyrone Ellis, 22, of no fixed abode, appeared before Kidderminster Magistrates' Court on Wednesday 18 September.

Both were charged with five counts of burglary non-dwelling, one count of burglary dwelling and one count of theft of a trailer relating to incidents in Hereford between December 2023 and March 2024.

They were further charged with offences relating to a violent disorder in Hereford on 15 April 2024.

Smith was charged with assault, possession of an offensive weapon, affray and two counts of criminal damage.

Ellis was charged with affray, possession of an offensive weapon and two counts of criminal damage.

They were bailed by magistrates yesterday to appear at Worcester Crown Court on Wednesday 16 October.

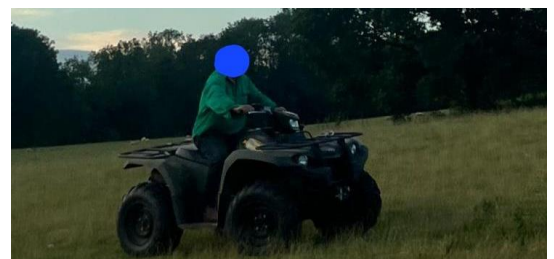


Stolen Quadbike

Youths accessing derelict buildings

There has been a recent increase in reports where groups of youths have been accessing derelict/abandoned properties across South Hereford.

We would like to remind people that these are private properties and forcing access to these properties could be illegal.

There are also concerns over the structural integrity of some of these properties. A range of these are unsafe to be accessed by unauthorised persons.

Previously, police have attended and spoken to a group of youths who have been accessing the Three Counties Hotel. Police will continue to investigate these incidents and identify those involved.



Zombie Style Knife Ban

A change to the Criminal Justice Act 1988 means that from the 24 September it is now be illegal to be in possession of a 'zombie style' knife and machete.

It will also be against the law to manufacture, import, sell or supply these items.

What if I have missed the deadline to surrender my weapon?

If you are still in possession, your possession will be unlawful unless you have a defence. You can still surrender items to the police, but you may be liable for prosecution having possessed it.
